

Fourth Grader Sarah Miller enjoys cataloging Half Moon Lake's weeds and is helping to keep our lake clean and healthy — by Kim Butler

We've all heard the expression "The apple doesn't fall far from the tree." A Half Moon Lake version of this adage might go something like, "A new Weed Ranger doesn't fall far from the rake"

This is truly the case of 9 year old Sarah Miller, who's already following in the footsteps of her dad, Rick Miller, a dedicated Half Moon Lake "Weed Ranger" since the program began in 2009 as part of the "Clean Boats/Clean Water" initiative. Approximately 6 lake residents volunteer to sample weeds from 5 locations around the lake several times each summer month. Sarah is probably the youngest "Weed Ranger". She and her parents Rick and Pam Miller have a cabin on Oscar Lane, and Sarah is the third generation of her family to enjoy summers on Half Moon.

This past summer, Sarah began accompanying her dad on all his weed collection trips on the lake. She showed an interest in the weed gathering, and began her own collection of lake weeds. She added, "I just thought it was fun." Sarah's elementary school in Inver Grove Heights, MN has an annual Project Fair each year, and she and her parents realized that Sarah's interest in lake weeds would make an excellent project. And so,

Sarah's Half Moon Lake Weed Scrapbook began.

Sarah explained that she has 25 weeds in her book so far, and fortunately she has no bad weeds. The process is pretty easy according to Sarah, "You get a rake and catch weeds." She and her dad collect weeds from the lake early in the morning when the lake is quiet, sometimes with the help of neighbor Brian Belanger. Sarah then puts them in a cooler to keep them fresh till they get home. Then Sarah rinses off the weeds and dries and presses them between pieces of scrap granite. Once dry, the weeds are laminated and go into her scrapbook.

Her dad helps her identify them but Sarah is conversant about lake weeds herself, noting that "Water Celery looks like long grass and grows to about 6'." She thinks collecting weeds "is fun, and keeps the lake clean and healthy."

She explained that the bad weeds they don't want to find are Eurasian Milfoil and Curly Leaf Pond Weed. According to Sarah, bad weeds like these "make it not as much fun to play in the water and it costs a lot of money to get rid of them," She's right. These 2 weeds are particularly invasive, non-native species which can clog lakes and lower property values an average of 13%.

Lake Minnetonka and the Minneapolis lakes in Minnesota have been particularly hard hit by Eurasian Water Milfoil. Closer to home, Bone, Balsam, and Deer Lakes all have evidence of Curly Leaf Pond Weed growth, which is costly to control and impossible to eradicate according to CB/CW Committee Chair Dan Leh. He also noted that some other county lakes are finding Eurasian Milfoil as well. Sarah knows that if she and her dad find either of these 2 weeds, they should contact Dan and Jeremy Williamson at the Polk County Land and Water Resources Department.

When asked what else she likes about collecting weeds, Sarah noted "It's fun, and it's quality family time. And you get to meet new people."

In closing, Sarah stressed, "We need more Weed Rangers."

If you would like to be a volunteer Half Moon Lake Weed Ranger, please email Dan Leh at halfmoonlake@hotmail.com. Training is available in May 2011, and volunteers are provided with 2 weed identification books, a video, and a hat. Dan stressed that being a Weed Ranger is not a time consuming commitment, "It's something you can do as you boat — you're on the water anyway." Sampling weeds takes about half an hour a few times a month. The other part of the CL/CW initiative involves monitoring boats and educating boaters entering Half Moon Lake at the Public Beach Boat Landing.


Who Can Vote

At any annual meeting of the Lake District and/or special meetings of the Lake District where voting will take place, voter registration is required. The Lake District gets its registration list from the Polk County Treasurer, who gets this from the Real Estate Tax Rolls. In some cases, the county treasurer has only one name listed as the owner of the real estate, even though in reality, more than one person, usually the spouse of the listed owner, also owns the real estate.


This creates a problem at registration time, since property owners may have up to two votes if the property is listed in two names. If the property is in a trust, then it would be listed as: John and Mary Doe Family Trust, or some similar wording.

A person or persons who own more than one piece of property are entitled to no more than one vote. Renters and lessees must bring proof of their eligibility to the registration. There are no absentee ballots or proxies.

CLEAN BOATS

The clean boats program was launched in June 2010! We hired Josh Hattan to inspect and educate boaters visiting during the weekends of June, July and August. Josh documented and asked boaters several questions regarding the Aquatic Invasive Species Law. He spoke with 565 boaters and observed 45 boats with weeds present, either entering or leaving the water. He suggested removal of plants and assisted with the removal if necessary. Josh became the Ambassador of the Lake each weekend and enjoyed meeting all of the lake visitors. He educated on the importance of keeping the lake free of Aquatic Invasive Species. Aiding Josh's efforts was the installation of the I-Lids camera. The camera captured all boat launches 24 hours a day and was an educational tool in itself. Many a boater was viewed stopping and removing weeds off their trailers. One interesting fact reveled by the camera was the amount of boats entering the lake each day. On a typical weekday 15-20 boats entered the water. On the weekends and holidays that number could reach 45-50. Boats were launched late into the evening and many were leaving the water between 2:00am - 4:00am. The camera made the local newspaper as the first boat launch camera in Polk County. We have made contact with the local DNR and they have agreed to contact boaters who launch weeds into the lake. We are looking forward to our second year of monitoring and working with the camera. We spring to start the 2011 boating season.

CLEAN WATERS

I am pleased to report that the summer of 2010 found no Aguatic Invasive Species in our lake. The Half Moon Lake Weed Rangers spent many volunteer hours identifying the aquatic vegetation that is native to Half Moon Lake. Our efforts to monitor the two boat landings and the river inlet/ outlet found only good aquatic weeds. We will be conducting a Weed Ranger training session in May to train all the new volunteers that identified themselves at the July District meeting. Thank you again for your support of the Clean Boats/Clean Waters Program. Please send me any suggestions or advice that could assist in our efforts. We will be attending the April 2011 Wisconsin Lakes Association convention in Green Bay and will report back all the combined knowledge from all Lake Districts in Wisconsin.



The History Corner

We all mourn the loss of Kent Bank, a one of a kind on Half Moon Lake. I met Kent soon after we bought our lake cabin in 1980. He served on the Lake District Board and was bothered when people said the lake was deteriorating. He initiated the Barr Engineering Study in 1991 that concluded in its 1994 report with a finding that the quality of the water in the lake had remained constant. When he decided in 1992 to retire as chair of the board, he asked me to serve on the board. He urged me to continue the work he had started to have the Board adopt a long range plan for the lake. At my first meeting of the board to elect officers I nominated Phil Siegle to serve as chair. Phil responded with, "Well no. Kent said you had agreed to serve as

Kent's grandfather, Mads Bank, who lived in Milltown at the time, was the first developer to lay out lots for lake cabins on

chair", so I did and I served for nine years.

Half Moon Lake. In 1920 he, along with Charles Johnson, platted the area called Pine View Beach on the north end of the lake, west of County Road G containing 18 lots. In 1923 he platted the area called Half Moon Beach, containing 14 lots, extending north and south along the east shore of the lake to the north end of what is now called Oscar Lane.

At the hearing in 1926, before the Railroad Commission of Wisconsin, on a petition to build a dam on Half Moon Lake, Mads Bank testified as follows:

O. MR. BANK, TELL US WHAT YOU KNOW ABOUT THE SITUATION.

A. Well, I ought to know a little, I have been here for thirty-four or thirty-five years now. I have known Half Moon Lake for thirty years, I lived up there ten years, and I know a little about the water.years before I know I been there at the outlet, went out fishing.

I fished there as much as anybody around, I do know the time I lived there the lake would vary not over 2 ½ feet from the spring to the dry times of summer.

DO YOU KNOW WHETHER THAT **OUTLET HAS BEEN LOWERED?**

A. I don't know. In behalf of the Polk Electric Light Company we are interested, are entitled to the flowage of Balsam Lake, that is our point. I am not in favor of lowering Half Moon Lake from the standard or raising it, leave it standard, as it was in the old days. I have nothing against it. We will get rain from now on for a month or two to fill up the reservoir - it will run down and raise us in Balsam Lake, each inch on Half Moon Lake gives us 78 hours' run, so that there is quite an item for us to get the water.

The yet to be researched question is: who built the first earthen dam that raised the lake level three feet and why did they do it and when did they do it? It must have been sometime after 1854 and before 1900.

- 1. Pick up pet waste from your yard
- Use only phosphorous-free fertilizer
- Know the rules and permits required before you build, dig, or clear vegetation in shoreland areas.
- 4. Restore and maintain your shore with a thirty-five-foot vegetative buffer
- 5. Learn the value of native aquatic plants and keep them in place
- 6. Keep roadside ditches clear of debris, grass clippings and leaves

Pete Johnson wants to improve communication and customer service

Laketown resident Pete Johnson won the November 2010 election for Polk County Sheriff, and will be sworn in this coming January. Current Sheriff Tim Moore opted not to run again. Johnson is currently an Investigator with the Polk County Sheriff's Department, and Moore has already begun including him in meetings to get up to speed on the budget and personnel issues. Johnson's worked for the department since 1999. Before that, he held law enforcement positions in Burnett County and Tomah, WI. He's a native of Trade Lake, and graduated from Grantsburg High School. He has a B.A. in Criminal Justice Administration, and lives with his wife and 3 high school aged daughters.

When Johnson takes office in 2011, he will head Polk County's largest department, with some 76 employees and a budget exceeding single biggest expense was personnel, including wages, benefits, and pensions. According to the proposed budget published at the Polk County website (http://www.co.polk.wi.us/and click on "Budget/Financial Reports" in the first column) the total levy increased by slightly less than \$380 thousand over 2010, or roughly 1.8%. Having such a small increase is a huge achievement, given the constantly rising fixed costs to which the county is subject, and it is entirely attributable to Dana Frey, our new county administrator and who assumed that position June 7. His vast knowledge and many years of experience are a tremendous asset to Polk County. In the past few years the finance committee, on which I sit, has struggled to limit the levy increase to 3% before debt service and Act 150 payments. A total increase of only 1.8% is remarkable, particularly since he did it without cutting any programs.

The county board passed a new nonsmoking ordinance at its October meeting that streamlines the process to enforce the state's smoking ban that went into effect in July, plus it allows the bulk of any fines levied to be retained by the county.

Township

As town Chair for Milltown I am happy to report that we are in good shape both financially and equipment wise. We are having our budget meeting Monday the 8th of November and I do not anticipate any big changes in our budget or mill rate. Due to finances some of our neighboring Townships have stopped tarring or rebuilding roads but we have been able to tar at least 2-3 miles of our 64 miles of roads each year.

We are trying to get funding to rebuild the fishing dock at the beach. We did remove the swim raft because of the vandalism. My phone is 715-205-7829 so please feel free to contact me with any questions or suggestions.
